RE: Legal Opinion Regarding Commission Has Authority To Make An Ordinance Effective Whenever It Determines It Should Be Effective

I reviewed the attached document, which includes language from the statutory text of section 166.041 of the Florida Statutes. At the end of the email, it cites to section 166.041(4) as to the effective date issue. That subsection provides, in part: "All ordinances or resolutions passed by the governing body shall become effective 10 days after passage or as otherwise provided therein." (emphasis added). It is my opinion that this language governs the issue of effective dates of ordinances and resolutions.

It is therefore my opinion that the Commission has the authority to make an ordinance effective whenever it determines it should be effective (as long as the date is provided in the ordinance). In other words, if the Commission states that the ordinance becomes effective upon adoption, it would become effective upon adoption. likewise, if the Commission states in the ordinance that the effective date is June 1, 2012, then that would be the effective date. Finally, if the Commission puts no effective date in the ordinance, than the 10 day period from the statute would apply, and the ordinance would become effective 10 days after adoption.
