RE: Legal Opinion Regarding City Business Tax Receipts For Complied Information

This afternoon I left you a voicemail concerning your recent public records request. This email is intended to provide you with more information regarding said request. On December 30, 2013, you requested, via email, that the City send you "the list of all new business tax receipts (formally occupational licenses) for the complete months of November and December 2013." More specifically, you stated, "I need the business name, owner's name, address, city, state, zip, type of business and phone number." The City, however, does not maintain such a list with the information that you requested. As such, City staff would have to compile, review, and sort information in order to create such a list or report for you. But Florida's Public Records Law does not impose such a burden upon public officials. See Florida Statutes, Chapter 119. Indeed, as stated in *Seigle v. Barry*, 422 So. 2d 63, 66 (Fla. 4th DCA 1982), *review denied*, 431 So. 2d 988 (Fla. 1983), "[i]t is not the intent of the [Public Records Law] to put public officials in the business of compiling charts and preparing documentary evidence. The intent is rather to make available to the public information which is a matter of public record, *in some meaningful form, not necessarily that which the applicant prefers.*" The Florida Attorney General also recognizes this distinction and in doing so has stated "the custodian of such records is not required to produce public records contained on a computer disk in another format to satisfy the diverse needs of the public. Copies of such records should be provided in the format in which they are maintained by the custodian... [t]herefore, it is my opinion that a custodian of public records is required by [Florida's Public Records Law], to provide a copy of a public record in its original format in response to a request for such a copy." Fla. Att'y Gen. Op. 1991-61; see also Fla. Att'y Gen. Op. 2008-29 (stating "[a]s this office has stated in a number of opinions, the custodian of public records must *provide a copy of public records maintained by that office in the format in which they are maintained. However, a public records custodian is not required to reformat records in order to comply with a request under Chapter 119.*")

(emphasis added). Accordingly, the City is not required to reformat its records so as to provide them in a particular format to comply with its duties under Chapter 119, and, as such, the City will not expend its limited resources to do so. *Id.* Nonetheless, the City, in its proprietary capacity, is willing to sort, reformat, and compile the information for you in the format you requested for a standard charge set by the City's Finance Department. Therefore, please let me know if you would like to submit such a request to the City's Finance Department. Finally, attached hereto is the sole City record that was *partially* responsive to your request. The document was only partially responsive because, as previously mentioned, the City does not maintain and is not obligated to maintain records in the format that you requested.
