RE: Legal Opinion Regarding Appeal Hearing, No Transcript

Date: October 20, 2014

On behalf of the City, it is my opinion that the appeal can proceed without a transcript as it is my understanding that the principal issue in the appeal is preservation of the tree (and not design of the residence, except as it impacts the tree). There is no transcript related to the tree preservation decision (as the decision was made by staff as an administrative matter, not as part of a public hearing). It is my understanding that the Board of Architects decision was appealed only to the extent that the tree was impacted by the design. The Board of Architects' expertise relates to design and aesthetics, not tree preservation, so a transcript from that proceeding on the tree preservation issue is not necessary. If the Commission determines that the design must be changed because of tree preservation, then the matter could be sent back to the Board of Architects for consideration of a new design. Please note, if the issue becomes more about aesthetics then tree preservation, a transcript from the Board of Architects decision may become relevant at that point based on the circumstances.

The transcript shall be provided seven (7) days prior to the City Commission meeting at which the appeal will be heard with a sufficient number of copies for the City Commission, the City Attorney, the City Manager and the affected departments.
