RE: Legal Opinion Regarding 2907 Columbus Blvd - Non-Conforming Setback

Date: May 9, 2018

I have reviewed the matter and the proposed revisions to the previously approved plans, specifically the gazebo, will not require a variance. This falls within prior legal opinions given by the City Attorney's Office relating to historically designated structures and Article VI of the Zoning Code. If otherwise in conformity with the Zoning Code, the addition, or in this case the gazebo, can be done along the established legally non-conforming setback line as long as (1) there is not further encroachment beyond the established legally non-conforming setback line and (2) the Historic Preservation Board approves a Special Certificate of Appropriateness in a publicly noticed, quasi-judicial hearing. See, e.g., CAO 2015-048. The City Commission would also have authority to review the matter if any affected party appeals. As indicated in CAO 2015-048, "one purpose of Article VI is to ensure that properties are not penalized for legal non-conformities. This is particularly true for historic properties where the City has made a policy decision that these properties should be historically preserved as originally built, which substantially restricts an applicant from being able to modify the structure to comply with the current setback in an historically appropriate manner."

This opinion is based on the specific facts of this matter and the proposed revisions to the previously approved plans and pursuant to Section 2-252(e)(1) and (8) of the City Code and Section 2-702 of the Zoning Code, authorizing the City Attorney's Office to issue opinions and interpretations on behalf of the City.
