RE: Legal Opinion Regarding Collection of Board of Architects Fee

Date: September 24, 2020

You have asked whether the 50 percent split of the Board of Architects (BOA) fee may be implemented prior to November 1st. The current fee schedule states that the BOA fee is "\$2.67 for each \$1,000 Construction Cost" but does not specify when the fee is to be collected. At the September 22^{nd} City Commission meeting, the City Commission adopted a resolution amending Ordinance No. 2015-17 revising various building permit fees. While the BOA fee did not change, as part of that item, the City Commission approved the addition of language specifying that the BOA fee will be collected in two parts – 50 percent prior to preliminary BOA and 50 percent prior to final BOA. That resolution goes into effect on November 1st. There are several projects in the pipeline that are ready to proceed to preliminary BOA and would like to avail themselves of the 50/50 payment option. You have asked whether the department may institute the 50/50 payment option prior to preliminary BOA, there is nothing that prohibits the 50/50 payment option from being instituted now. In addition, the City Commission has indicated with their vote that they are in agreement with this option.
